

## PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT

## FOR THE CONTROL OF WINDMILL GRASS IN SUMMER FALLOW

## **CONDITIONS OF USE**

#### **Products to be used:**

ALL REGISTERED PRODUCTS

Containing either: 99.5 g/L, 100g/L or 200g/L QUIZALOFOP-P-ETHYL as their only active constituent.

#### **Directions for Use:**

Situation	Weed	Product & Rate
Summer fallow	Windmill grass	<b>99.5</b> g/L & 100 g/L products: 500mL to 1 L/ha
		<b>200 g/L products:</b> 250 to 500 mL/ha

## **Critical Use Comments:**

- Apply as foliar application by boomspray to actively growing windmill grass at the 3 leaf to early tillering stage.
- Apply in a minimum total spray volume of 70L/ha.
- Add Hasten at 1L/100L of spray solution.
- Apply one application per season only.
- DO NOT apply to weeds that are stressed by any cause (such as severe weather conditions, drought, water-logging or not actively growing). Grass weeds under stress frequently become less susceptible to herbicide activity. This may result in an incomplete kill or suppression of weeds only.

# Resistance Management

■ To ensure effective control and to aid in resistance management, application of Quizalofop-p-ethyl must be followed within 7 days by a treatment of paraquat applied at a minimum rate of 1.6 L/ha (using 250 g/L paraquat product).

## Withholding Period:

DO NOT graze or cut for stockfood for 4 weeks after application.

NSW only.

THIS PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.
